With a combined academic, operational, and instructional background, I specialize in the evaluation and application of ethical, evidence-based interview and interrogation techniques. My work spans over four decades, more than 50,000 hours as an instructor, and includes documenting and analyzing over 1,500 interviews across 40 U.S. correctional institutions, including the U.S. Disciplinary Barracks at Ft. Leavenworth, KS and Changi Prison in Singapore.

I've trained law enforcement personnel at agencies and academies in 40 U.S. states and provided instruction to investigators in Canada, Australia, New Zealand, Singapore, the Netherlands, and the United Arab Emirates. My client base includes local, state, federal, and international agencies, as well as military and intelligence units.

Military instruction spans 20 U.S. and overseas bases, including training for U.S. Army Special Operations Command, 82nd & 101st Airborne, U.S. Cavalry, U.S. Armored Battalions, 1st, 3rd, 4th and 25th Infantry Divisions and the U.S. Air Force Office of Special Investigations, U.S. Air Force S.E.R.E. School. These techniques were deployed in live combat and intelligence operations during the Gulf War for counterintelligence and military field operations. I've been a repeat guest instructor at the U.S. Army Criminal Investigation Division and Military Police School and have trained personnel from: FBI, DEA, U.S. Secret Service, BATF, U.S. Customs, Immigration Services, U.S. EPA, State & Local Environmental Protection Agencies, U.S. Probation & Pretrial Services (U.S. Administrator of Courts), U.S. Indian Police Academy, and NASA Inspector General's Office.

Specialized instruction has also been delivered for fire and arson investigators, including presentations for state and local chapters of the International Association of Arson Investigators and at the National Fire Academy in Montour Falls, NY.

I contributed to a major research initiative sponsored by John Jay College, the NYPD, and the U.S. State Department, producing three published papers that were presented before the

American Psychological Association. I served as a co-developer in conjunction with Johns Hopkins University, creating the first interactive DVD training course on interview and interrogation for the FBI Training Academy.
